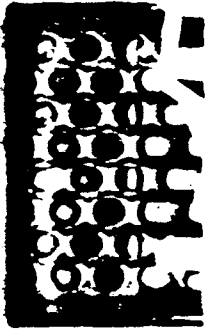
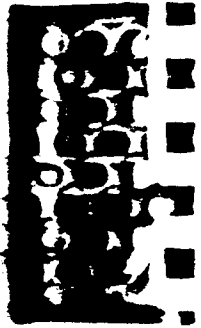

After running through dry run, Mother pulled into parking lot of 7-11 on Josephine and Colfax. Mother called CMD to report. Mother then returned to automobile. Stroller #1 (sitting in back seat of auto.) made final preparation of packages for delivery. Mother then proceeds up Colfax to Colfax and Cherry. Mother drops off Stroller #1 and proceeds one (1) block to Colfax and Dexter and turns right onto Dexter. Stroller #1 proceeds up Cherry toward site. Mother drops off Stroller #2 on Dexter about three (3) houses from corner. Stroller #2 proceeds up Dexter toward site and Mother proceeds towards In the Grass. Stroller #2 arrives at site first. A car coming down 14th; so Stroller #2 goes into alley directly behind site as Stroller #1 crosses 14th and walks toward site. Small car turns down Cherry traveling toward Colfax; Stroller #2 transmits "All Clear" as Stroller #2 enters alley, seeing Mother at the corner of 14th and Dexter. Stroller #1 crosses street and enters alley.

Once in alley, see that windows upstairs are open; basement windows (behind re-bar) are open; First (1st) floor windows are closed, however there are no screens on them.

Strollers #1 & #2 set materials down and remove packages from bags. Stroller #2 throws brick through window;

Stroller #1 throws cocktail; Stroller #2 has to strike match two or three times so Stroller #1 throws timer through window. Stroller #2 gets cocktail #1 and throws through window as stroller #1 leaves alley. Stroller #2 then throws

timer through window. Right after throwing timer through window, Stroller #2 hears a blast and sees flames

as Stroller #2 leaves alley. Stroller #2 crosses 1st as Stroller #1 proceeds In the Grass, followed by Stroller #2

Police Patrol: No sign of any patrol on 14th; No activity near building on Colfax (police engaged in robbery investigation on Colfax near Paul)

Neighborhood watch: a few windows open (mostly back of houses) music coming from house directly across the street on Cherry

Activity of people in Area: No visible activity

Perimeter/strong pt: Fencing along side of building (wooden fence belonging to house next door 6ft. tall) No alarm box noticed

Weak points of Dwellings: open window in back of building on top floor; No guards, intercom noticed (window ~~is~~ opened upstairs in apartment building directly behind building)

Lighting on street/alley: ~~spotting~~ ~~several~~ spot light bulb on back of building approx. 10 ft. high; light bulb on corner of garage ~~of house~~ ^{behind} apartment building (approx. 25 ft.); ~~street~~ Cherry street very well lit near building

Trucks/cars in Area: not activity

Is there a good chance of anyone being made: only shadow visible in alley; front and side very well lit and possibility of someone being made, but no activity present

parking of car: parking near corner of 14th & Dexter with pointing north towards Colfax

Running and Walking rout in; out: big boy, motel on Colfax also motel just as you turn corner from Colfax onto Colorado Blvd.

Busses: No busses running that time at night (2 to stop on Colfax)

Police Station: reportedly one several blocks away (did not see) 11/2/68
