NARRATIVE	

On January 25, 2006, I was involved in repackaging evidence in this case. Crime Laboratory Coordinator Bob Blackett checked out the evidence and was present for the packaging. I responded to the screening room in the TPD Crime Lab, along with Detective Ed Salgado, Sergeant Kevin Hall, Lieutenant Reuben Nunez, Deputy County Attorney Bill McCollum, and Crime Scene Specialist Jesus Valenzuela.

Photographs of the packaging were taken, and I repackaged the following items based on today's standards: 8TM, 15TM, 47TM, 9TM, 17TM, 107TM, and 42TM. I did not repackage, but only added current tape to the following items: 2TM-4TM, 16TM, 14TM, 1Lab(4) and 2Lab(18). Detective Salgado recorded the item numbers.
