AT APPROXIMATELY 1030 HRS. I RESPONDED BACK TO THE LOCATION OF THE INCIDENT. SGT. GRIDER INSTRUCTED ME TO CHECK SEVERAL DAYCARE CENTERS IN THE AREA TO LOCATE THE CHILD OF A POTENTIAL WITNESS/SUSPECT, WHO WE WERE NOT ABLE TO CONTACT.

THE CHILD, [REDACTED], WAS IN FACT REGISTERED AT BROADWAY/HIGHLAND BUT WAS NOT DUE TO START THE PROGRAM UNTIL 2-1-90. I ADVISED SGT. GRIDER AND COMPLETED THIS REPORT
