I RESPONDED TO STATED LOCATION REFERENCING A POSSIBLE HOMICIDE. UPON ARRIVAL I SPOKE WITH SGT RAY WHO INSTRUCTED ME TO SECURE 739 E 6TH ST IN THE COMPLEX. INSIDE WERE 3 ADULTS AND THEIR 3 CHILDREN. THESE SUBJECTS WERE SEPARATED FOR SGT RAY. OFFICERS WALKER, KURTZ & MYSELF WERE IN THE APARTMENT. I SPOKE WITH SAID KHALIFA WHO WAS THE VICTIM'S SISTER. SHE TOLD ME SHE DID NOT HEAR OR SEE ANYTHING THAT HAD HAPPENED. SHE DID SAY SHE HAD GONE INTO THE 749 E 6TH WITH THE CHURCH SECRETARY AFTER THE INCIDENT. HE WAS LYING OUTSIDE HIS OFFICE AT THE CHURCH STABBED NUMEROUS TIMES. AFTER DETECTIVES ARRIVED I WAS ADVISED BY SGT RAY TO HAVE THE ADULT SUBJECTS TRANSPORTED TO THE MAIN STATION FOR DETECTIVE INTERVIEWS. OFFICERS ORourke, WALKER, & KURTZ TRANSPORTED SUBJECTS IN SEPARATE VEHICLES. I WAS THEN INSTRUCTED BY SGT RAY TO GET WITNESS INFORMATION IN ADJOINING APARTMENT & PASS
